Congratulations to our 2009 and 2010 Leverage League "bull trophy" winners! If you're a graduate of our Financial Independence courses, you're eligible to participate in our investment club. We meet every second Monday evening from September to June.

We had our final meeting/awards dinner banquet at the Silver Stallion restaurant in Des Plaines where we awarded the top three finishers. We compete to see how big you can grow a (fake) \$10,000 investment in nine months. Both seasons, twenty or more traders competed. By May, only a few were still in the contention for the coveted first place trophy.

Sally Gaylord took first place in 2009. She turned her portfolio into a \$15,554,312. Sally has also taken first place in 1996 and 1989. Keith Nyborg took first place in 2010 finishing with \$19,994,186. Both only traded three times during the seasons.

Sidney Joseph took second place both seasons with \$15,236,388 in 2009 and \$914,214 in 2010. He also took second place in 2005 and a third place in 2001.

Myron Gaylord took third place in 2009 turning his portfolio into \$10,948,792. It's unusual for Myron to take a 2nd or 3rd place trophy. Generally, it's all or nothing as evidenced by having taken 1st place 9 of the last 16 years. Adella Zunas took 3rd place in 2010 with \$214,956. This is Adella's fifth trophy in the last 18 years.
